## AMENDMENT REGARDING NORMS FOR FACULTY RECRUITMENT IN SFI INSTITUTES

Read: 1. Resolution of Academic Council dated 09.08.2018 & 26.04.2019

#### CIRCULAR:

All institutes/colleges were prior informed to follow recruitment rules of AICTE from 01/04/2019 vide circular no. 10256 dated 14<sup>th</sup> October, 2019.

Now, as per the latest APH-2020-21, in compliance to the order dated 08/11/2019 passed by the Hon'ble Supreme Court of India in CA No.364/ 2005, for the Institutions intending to offer Courses in Architecture Programme, approval by the Council of Architecture is mandatory.

As well as in compliance of the Hon'ble Supreme Court of India Order dated 05.03.2020 in Transferred Petitions (Civil) No.87-101 of 2014, PCI Approval for Pharmacy Institutes is mandatory. However, interested Institutions may obtain AICTE approval.

The A.C. noted the orders of the Hon'ble Supreme Court of India regarding COA and PCI and resolved that GTU must adopt recruitment norms made by concern apex body for endorsement of faculty members at affiliated institutes' i.e.

- 1. For all Engineering/MCA/MBA/Diploma courses: AICTE Norms
- 2. For all Architecture courses: COA Norms.
- 3. For Diploma, U.G., P.G. All Pharmacy Courses: PCI Norms.
- For Diploma, U.G., P.G. All Pharmacy Courses: PCI Norms & AICTE Norms, if Institute has voluntary applied in AICTE too.
   For Pharmacy, Diploma Pharmacy PCI Norms & AICTE Norms, if applied in both.
- All the SFI Institutes/Colleges are hereby informed to follow recruitment rules of concern Apex bodies, i.e. AICTE/COA/PCI/AICTE & PCI, if applied in both, as per the resolution of Academic Council dated 19<sup>th</sup> March 2020 now onwards.
- Other instructions are remaining same as per the circular no. 4761 dated 04/06/2019 till further instructions. (Norms for Faculty Recruitment in SFI Institutes-2019)
- All the SFI Institutes/Colleges are hereby advised to strictly follow the said instructions.
