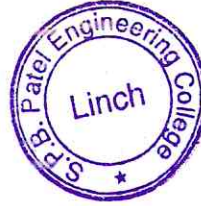

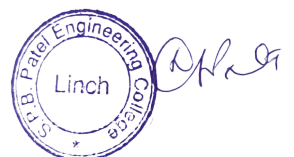
Session Overview:
